WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Maryland Volleyball Camps and Clinics, LLC ("Releasees") has put in place preventative measures to reduce the spread of COVID-19; however, Maryland Volleyball Camps and Clinics, LLC cannot guarantee that you or your child(ren) will not become infected with COVID-19, or other infectious diseases. Further, attending Maryland Volleyball Camps and Clinics camp programming could increase your risk and your child(ren)'s risk of contracting COVID-19.

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT In consideration of being allowed to participate in Maryland Volleyball Camps and Clinics, LLC (herein after referred to as MVCC) events and related activities, the undersigned acknowledges, appreciates, and agrees that:

- 1. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and.
- 2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS regarding transmission, contraction, diagnosis of or effects of COVID-19, or other infectious diseases, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- 3. I understand and know there are both unknown and known symptoms of COVID-19, and by signing below I am releasing that I am not showing symptoms and have not shown symptoms in the last 14 days (e.g. cough, shortness of breath, fever, headache, chills, muscle pain, sore throat, new loss of taste or smell, vomiting, etc.)
- 4. I willingly agree to comply with the stated and customary terms and conditions for participation in regards to my protection against infectious diseases, including COVID-19. If, however, I observe any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- 5. I willingly agree to alert MVCC if I have reason to believe I have contracted COVID-19 or any other infectious disease, and it is my responsibility to take reasonable steps to avoid passing said disease to others, including, but not limited to, leaving any activities put on by or done in conjunction with MVCC, self-isolating or quarantining away from events and activities of MVCC and getting the advice of a medical doctor/health care provider (as MVCC is not an expert)
- 6. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS (MVCC) their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT. By signing this agreement, I specifically acknowledge the contagious nature of COVID-19 and other infectious

diseases and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19, or other infectious diseases, by attending MVCC camp programming and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19, or other infectious diseases, at University of Maryland may result from the actions, omissions, or negligence of myself and others, including, but not limited to, MVCC employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance or participation in MVCC summer camp programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless MVCC Club its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of MVCC, its employees, agents, and representatives, whether a COVID-19 infection, or other infection, occurs before, during, or after participation in any MVCC camp programming.
